Pogoji za vključitev v delo oz. za opravljanje študijskih obveznosti:

Za vključitev v delo in opravljanje študijskih obveznosti pri tem predmetu ni posebnih pogojev. Vendar se priporoča predhodno poznavanje osnov teorij spomina in zgodovine, saj bo to olajšalo razumevanje obravnavanih tem in aktivno sodelovanje v diskusijah ter praktičnem delu. Študentke in študenti morajo biti pripravljeni na branje in analizo kompleksnih teoretskih besedil ter na sodelovanje pri terenskem delu in intervjujih.

### Prerequisites:

There are no specific prerequisites for participating in this course and completing its requirements. However, prior knowledge of basic theories of memory and history is recommended, as it will facilitate understanding of the topics discussed and active participation in discussions and practical work. Students should be prepared to read and analyse complex theoretical texts, and to engage in fieldwork and interviews.

### Vsebina:

Vsebina predmeta zajema razmerje med individualnim in kolektivnim spominom skozi soočenje teoretskih izhodišč Maurica Halbwacha, Andreas Huyssena in Aleide Assmann. Vključuje opredelitev spominske pokrajine in seznanitev s problemi pri

### Content (Syllabus outline):

The content of the course includes the relationship between individual and collective memory through the theoretical frameworks of Maurice Halbwachs, Andreas Huyssen, and Aleide Assmann. It covers the definition of memorial landscapes and introduces the challenges in

opredelitvi osnovnih pojmov, kot so revizionizem, negacionizem in drugi. Predmet vključuje tudi praktično delo z informanti ter primerjavo političnih intervencij v zgodovinopisje od sredine 20. stoletja naprej, pri čemer se soočajo socialistični/komunistični in revisionistični/negacionistični načini reinterpretacije prelomnih dogodkov evropske in slovenske/jugoslovanske preteklosti. Posebna pozornost bo namenjena analizi slovenskega primera (pre)oblikovanja spominske pokrajine po letu 1991.

The course also involves practical work with informants and a comparison of political interventions in historiography from the mid-20th century onwards, addressing the confrontation between socialist/communist and revisionist/negationist reinterpretations of pivotal events in European and Slovenian/Yugoslav history. Special attention is given to the analysis of the transformation of the memorial landscape in Slovenia post-1991.

**Cilji in kompetence:**

Sklop predavanj in seminarjev bo usmerjen v razumevanje razmerja med spominom in zgodovino. Uvodni del bo posvečen spoznavanju treh generacij utemeljiteljev in zagovornikov spominskih študijev. Študentke in študenti bodo imeli možnost spoznati razloge, okoliščine in tehnike (pre)oblikovanja individualnega in kolektivnega spomina, z jasnim poudarkom na razlikah med njima. Ob spoznavanju različnih dimenzij in tipov spominske pokrajine bodo na podlagi svojih tem spoznavali prednosti in slabosti strukturiranih ali zaprtih narativnih ter odprtih in kombiniranih intervjujev. Poleg tega se bodo na podlagi konkretnih primerov in ekskurzij naučili brati in analizirati govorico različnih tipov spominske pokrajine srednje in jugovzhodne Evrope. Pri izvedbi programa

**Objectives and competences:**

The series of lectures and seminars will focus on understanding the relationship between memory and history. The introductory part will present the three generations of founders and advocates of memory studies. Students will learn about the reasons, circumstances, and techniques of (trans)forming individual and collective memory, with a clear emphasis on their distinctions. By exploring different dimensions and types of memorial landscapes, students will understand the advantages and disadvantages of structured/closed and narrative/open interviews through their thematic assignments. Additionally, through concrete examples and excursions, they will learn to read and analyse the language of various types of memorial landscapes in Central and Southeastern Europe. The course will be

delivered in collaboration with Austrian, Serbian, and Hungarian lecturers, who are experts in the memorial landscape of the First World War in western Serbia, concentration camps (Mauthausen, Hartheim), and the Memento Park in Budapest. They will help students understand the difference between primary and secondary material sources and introduce them to the basic techniques of different politics of the past.

#### Predvideni študijski rezultati:

#### Intended learning outcomes:

Students will use the knowledge acquired in the course to produce a scientific contribution that can serve as a draft of a dissertation chapter or a research article. In doing so, they will develop the ability to critically analyse and interpret the processes of collective memory in a historical perspective and enhance their academic writing skills, contributing to their scientific and professional development.
