An application is considered timely if it has been completed and submitted via the [eVŠ](#) portal by the deadline specified in the call for enrolment.

Regardless of the method of application, applicants must send all required attachments by registered post or deliver them in person, in accordance with the call, to the address above.

- Certificate of completion of previous studies – a certified copy of the diploma (if already completed); for foreign documents, a certified Slovenian or English translation is required.
- Transcript of records – a transcript showing all examinations passed with the calculated average grade (excluding the diploma grade); for foreign applicants, certified translations into Slovenian or English are required.
- Diploma thesis grade certificate – a certificate stating the grade of the diploma or master's thesis.
- Curriculum Vitae (CV).
- Bibliography and link to the online version of the diploma or master's thesis.
- Statement of purpose – a brief outline of the applicant's study interests and reasons for enrolment.

Notes for foreign applicants:

- All documents issued abroad must be officially certified and accompanied by a certified translation into Slovenian or English.
- Originals or certified copies must be sent by registered post or delivered in person, in accordance with the application instructions. The original or a copy (duplicate) of a certificate or diploma that requires recognition or of any other document that, according to the law of the issuing country, replaces the original.

## 6.C RECOGNITION OF FOREIGN EDUCATION:

If applicants have completed their studies in a country other than Slovenia and wish to continue their studies in Slovenia, they must initiate the procedure for recognition of their foreign qualification for the purpose of further study together with their enrolment application.

## 7. CONDITIONS FOR ENROLMENT IN THE SECOND OR THIRD YEAR (PREVIOUSLY: ACCORDING TO THE TRANSITION CRITERIA):

Students who wish to transfer from other doctoral programmes to a higher year in the Third-Cycle (Doctoral) Study Programme in [Environmental and Regional Studies](#) may do so if they meet the following conditions:

Students and graduates of any doctoral programme at any higher education institution shall have their completed study obligations recognized if they meet at least 70% of the content and standards of the subjects in the Third-Cycle (Doctoral) Study Programme in Environmental and Regional Studies at the Postgraduate School ZRC SAZU.

For direct entry into the second year, applicants must have earned the same number of ECTS credits as required in the Third-Cycle (Doctoral) Study Programme in [Environmental and Regional Studies](#), i.e., at least 42 ECTS. Otherwise, they may only enrol in the first year.

Graduates of postgraduate programmes completed before 11 June 2004, who obtained a Master of Science degree or specialization after completing an undergraduate programme leading to a university degree, as well as holders of a Doctor of Science degree (PhD), may, upon enrolment in this Third-Cycle (Doctoral) Study Programme in Environmental and Regional Studies, have up to 60 ECTS credits recognized.
